## DRINKING WATER NOTICE

### Monitoring or Reporting Requirements Not Met by Sumner Co RWD 5

Sumner Co RWD 5 public water supply system violated some drinking water standards. Even though this was not an emergency, as our customers, you have a right to know what happened and what we are doing to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During first quarter (January-March) 2014 and second quarter (April-June) 2016, we did not complete some required monitoring for Disinfection Byproducts as required by Kansas Administrative Regulations, and therefore cannot be sure of the quality of our drinking water during that time.

**What happened:** We missed a sample date.

**What you should do and who is at risk:** This is not an emergency. There is nothing you need to do at this time. There is no direct health risk to consumers.
